**Selection results:** OPEN CALL for short-term *visiting lecturer* in Bioethics and Biolaw with PHD in Philosophy of Law, at Federal University of Espirito Santo, Vitoria, Brazil.

This is with reference to the Erasmus Plus Project - Learning Mobility of Individuals - Higher education Student and Staff Mobility (KA107) Project code 2019-1-IT02-KA107-061621 Call 2019 Round 1, for the selection of 1 short-term visiting lecturer staff mobility for teaching in the field of Bioethics and Biolaw from the University of Milano-Bicocca, in Milan, Italy.

In order to select the candidates, the Evaluation Committee, comprising of 3(three) Members met on the 8<sup>th</sup> April 2021 at 1 p.m. in videoconference mode via Google meet platform.

The Evaluation Committee has examined the application received to the open call for short-term visiting lecturer in Bioethics and Biolaw to teach at the Federal University of Espirito Santo, Vitoria, Brazil. The selection process takes into account the principles of equity, fairness and transparency, respecting the principles of non-discrimination set out in the Program.

As per the selection criteria outlined in the Call, the Evaluation Committee has assessed the candidate based on Curriculum and Qualifications (up to 80 points) and Language Proficiency (up to 20 points). Besides this, the following other criteria have also been considered:

- the applicant's previous teaching experience on the topics as abovementioned
- specific research projects on bioethical and biolegal issue
- publications on the topics as abovementioned in English and, possibly in Portuguese
- supervision of academic papers of students on the topic of the proposed courses
- knowledge of the bioethical context of the hosting country
- the applicant's availability to travel during the period indicated in the call
- ability to teach in English
- Language skills: Degree of translation
- The applicant's adaptability and attention to cultural differences

Based on the above, the results of the selection are as below:

- Language Proficiency: 20 points






